# Car Hire Terms and Conditions Lefkas, Parga, Sivota and Meganissi 2025

Important: Please note that the prices quoted are approximate and subject to change locally.

### **Included in your rental:**

- 1. Unlimited mileage and fire protection.
- 2. Collision Damage Waiver (CDW) with an excess of 600 Euros for groups B and C, 850 Euros for groups C2, D and D2 and 950 Euros for groups J2 and L.
- 3. Personal accident insurance and theft protection insurance.
- 4. Third party liability and property damage.
- 5. Free delivery and collection from the airport and all accommodation on Lefkas.
- 6. Free second driver.
- 7. Substitution of vehicle in case of breakdown anywhere.
- 8. Child seats are available free of charge.

### The following conditions apply to our car hire rentals:

- 1. Meganissi delivery and collection charges to and from the port of Spilia or Vathy is 16 Euros per way (client to meet ferry); to and from Meganissi accommodation is 32 Euros per way.
- 2. Delivery and collection to Parga is 80 Euros each way.
- 3. Delivery and collection to Sivota and Igoumenitsa is 100 Euros per way.
- 4. Insurance for underside and wheels is available at 5 Euros a day.
- 5.FDW (which includes underside and wheels insurance) is 10 Euros per day for groups B and C and 12 Euros for all other groups.
- 6. If the interior of the car is excessively dirty on collection a 20 Euros cleaning charge will apply.
- 7. Minimum age is 21. For all car hire groups, each driver must have held a full UK or EU driving licence for 1 year. Maximum age is 77.
- 8. Clients aged 78 and over are able to drive but would have third party insurance only so liable for cost of any damages.

#### **Notes:**

- 1. The insurance becomes invalid if anyone whose name is not on the contract drives the vehicle, the vehicle has more passengers than the stated capacity or if the driver is under the influence of alcohol or drugs.
- 2. The insurance will also lapse in the event of negligence or if the vehicle is driven on unsuitably narrow or unmade roads.
- 3. The insurance does not cover interior damage or loss or damage of the car key, Vehicle documents, registration plates or any additional equipment provided with the vehicle.
- 4. Clients must contact EURODEALAUTO car rental supplier in the event of any damage.
- 5. If a collision occurs, a Police report and case number must be provided. If not then the insurance will become invalid.
- 6. All local charges are subject to VAT at 24%.
- 7. Those with a car from the Airport should remember that luggage space is limited. It is recommended that you therefore limit luggage to one medium sized suitcase per person. Excess luggage may have to be transported by taxi, the cost of which would be payable locally.
- 8. The contract you sign on delivery of the car is between you and the car hire company. You should therefore read this and inspect the car and tyres before driving. The companies we use are all reputable firms who have been operating for many years.
- 9. Refunds for unused car hire, including cars returned early, are at the discretion of the car hire company and should be agreed with them before returning to the UK.
