

# **Spain - Car Hire Terms & Conditions 2021-2022**

**Important:** Please note that the prices quoted are approximate and subject to change locally.

#### Included in your AVIS rental

- 1. Unlimited mileage.
- 2. Collision Damage Waiver (CDW). In the event of an accident or theft of the rental car this insurance covers the full value of the vehicle. However, you remain liable for the excess amount of: 1,344 Euros (Groups A & B); 1,694 Euros (Groups C, D & E); 1,936 Euros (Groups F, G, H & N); 2,178 Euros (Groups I, J & K); 3,025 Euros (Group L); and 2,420 Euros (Groups M, O & P). Please note that this insurance does not cover damage to the vehicle's tyres, undercarriage or windscreen.
- 3. Third Party Liability Insurance. This covers any third party in the event of an accident.
- 4. Airport service charge.
- 5. VLF (Vehicle License Fee) and VAT at 21%

### Not included and payable locally (optional)

Please note that you do not have to purchase any of the below. Should you decide to do so, these will be noted on your rental agreements and be payable locally.

- 1. Super Collision Damage Waiver Insurance (SCDW). This is an extra charge, which if paid, will void any excess payable in the event of an accident or theft of the rental car. The price depends on the vehicle and location but you can expect it to cost between 14 to 45 Euros per day. If you rent the vehicle for more than 10 days, you will be charged for a maximum of 28 days and get cover for the duration of your rental, up to 28 days.
- 2. Personal Accident Insurance (PAI). This insurance will cover the cost of any personal medical costs incurred in the event of an accident. This insurance is optional and payable locally at between 4-6 Euros per day. If you rent the vehicle for more than 10 days, you will only be charged for a maximum of 28 days and get cover for the duration of your rental, up to 28 days. Please check with your insurance company prior to departure to see if you are covered.
- 3. Each additional driver will be charged locally at 10-12 Euros per day. You will only be charged for a maximum of 10 days and get cover for the duration of the rental.
- 4. A one-way supplement applies if the drop off point is different from the collection point. This charge must be paid locally and you can expect to pay between 49-89 Euros depending on the rental location.
- 5. No smoking permitted in the vehicles, If caught then a specialist cleaning charge will apply.
- 6. Any applicable after hours airport charges. The afterhours charge is 71.65 Euros.
- 7. Any applicable delivery and collection charges details on request.
- 8. Infant and booster seats are compulsory with all car rentals in Spain and payable locally. The cost is between 10-15 Euros per day depending on the rental location. If you rent the vehicle for more than 10 days, you will only be charged for a maximum of 28 days and get cover for the duration of your rental up to 28 days. Please request at the time of booking. A baby seat is typically suitable for a child from birth to 12 months old and weighing no more than 13 kilos. An infant seat is typically suitable for a child aged 9 months to 4 years old and weighing between 15-36 kilos. A booster seat is typically suitable for a child aged 8-11 years old and weighing between 20-45 kilos.
- 9. GPS Navigation System equipment is available to hire at a rate of between 15-17 Euros per day. This equipment is only available for rentals collected and returned to the same airport. If you rent the vehicle for more than 10 days, you will only be charged for a maximum of 28 days and get cover for the duration of your rental up to 28 days. Please request at the time of booking.

Note: Sunvil recommend that clients hire a GPS (if not taking their own Satnav or mobile phone navigation app).

### General notes

1. Cars will be supplied with a full tank of petrol. Clients will be required to leave a credit card imprint corresponding to a full tank of petrol. This deposit will be refunded when the car is returned with a full tank of petrol. Any missing fuel on the return of the vehicle will incur an additional service charge, payable locally. Please note that the credit card needs to be in the name of the designated driver. All major credit cards accepted.



- 2. Driving is on the right.
- 3. A valid, full UK, EU or international driving licence is required, issued not less than one year prior to rental.
- 4. Minimum driver age is 21yrs (Groups A-J) and 25yrs with a driving licence issued not less than two years prior to rental (Groups K-P). Young drivers aged between 21-25yrs are charged a supplement of between 20.95 and 25.00 Euros per day (maximum 209.63 Euros per rental). No maximum age limit
- 5. We can request, but not guarantee a particular make of car.
- 6. We are not liable for any police or traffic fines incurred by clients.
- 7. These conditions also apply to car hire already included in the cost of our holiday.
- 8. All local charges guoted here include VAT (21%).
- 9. Airports are open 365 days a year. Airport office hours vary, but generally the major airports open between 08:00-22:00.
- 10. Please advise us, at the time of booking, of any ENDORSEMENTS ON YOUR LICENCE.
